### Keep the Heat on with HEAP!



Here at Steuben Rural Electric we want you to know there are resources available to help you with your electric bills. First and foremost, contact us as soon as possible if you cannot pay your bill on time. Your household may be eligible for the Home Energy Assistance Program (HEAP).

HEAP helps low-income New Yorkers pay for their energy bills. If your bills are more than you can handle, HEAP may be able to help you heat your home.

You may be eligible for a Regular HEAP benefit if:

- You and your household members are United States Citizens or qualified aliens and;
  - Your household's gross monthly income is at or below the current income guides for your household size. The guidelines can be found at: otda.ny.gov/programs/heap or;
- You receive Supplemental Nutrition Assistance Program (SNAP) benefits or;
- You receive Temporary Assistance or;

You receive Code A Supplemental Security Income (SSI Living Alone).

HEAP benefit amounts will vary depending on your household income and may be available even

if your heat is included in your rent. You may be eligible for a regular HEAP benefit even if you have money in the bank, stocks, bonds or other resources.

What if you have an energy emergency? If you have an energy-related emergency, such as a utility termination notice, you can apply for a HEAP emergency benefit at your local department of social services. If you are eligible, a HEAP

emergency benefit may be issued in addition to your regular HEAP benefit, if the regular benefit has been exhausted.

You may be eligible for a HEAP Emergency Benefit if:

- Your income is at or below the current income guidelines, or you receive Family Assistance, Safety Net Assistance, SNAP or Code A Supplemental Security Income, and you do not have available liquid resources to meet the emergency and;
- Your natural gas or electric heat is off or scheduled to be terminated or;
- Your electricity is necessary for your heating system to work and it is either terminated or schedule to be terminated.

The only way to know if you qualify is to apply. Check your eligibility for a range of benefits and apply for HEAP at myBenefits.ny.gov. To find out when HEAP benefits are available during the year, visit otda.ny.gov or call 800-342-3009.

In light of those decisions, the Board decided to offer the members a "drive-thru" chicken barbecue as a token of appreciation for member's understanding and acceptance of the restructured format.

On Saturday, October 17, 2020 members picked up their reserved chicken barbecue dinners at the Bath and Cherry Creek Offices from 11:00 am - 2:00 pm. At the time of pickup, members were provided with a calendar, information packet containing all reports that would have typically been provided during the business portion of the traditional meeting and their reserved dinners. ## **Beneficial Electrification**

What is beneficial electrification? Beneficial electrification means using electricity as a power source, where it makes sense for the consumer, as an alternative to fossil fuels. Beneficial electrification is a new approach to the energy sector that looks at energy consumption across the economy.

New York State Rural Electric Cooperatives are uniquely positioned to capitalize on emerging technological advances that reduce greenhouse gas emissions in a way that is cost-effective for our members. As you are likely aware, 85% of Steuben Rural Electric Cooperative's purchased power comes from the New York Power Authority's Robert Moses Niagara Power Plant in the form of low-cost. clean, hydropower. As a result, there are several benefits when a member converts a fossil fuel appliance to electricity that is derived from a clean renewable resource. There are numerous

opportunities to reduce your carbon footprint and potentially save money in the process. Opportunities can be found in transportation, water heating, cooking and so much more!

The Cooperative looks forward to offering several fossil fuel conversion incentives that promote the concept of beneficial electrification. To be an effective beneficial electrification incentive program, it must satisfy one (or more) of the following without adversely affecting the others:

- Saves consumers money over time;
- Benefits the environment and reduces greenhouse gas emissions;
- Improves product quality or consumer quality of life;
- Fosters a more robust and resilient grid.

These 4 pillars of beneficial electrification are the key principals to ensuring that programs meet the needs of the members and the Cooperative as a whole. Through the use of rebates and energy efficiency obtained from newer appliances, members will be incentivized to convert certain appliances as they have a tangible benefit of cost savings. Due to advances in newer technologies, many of these appliances in your home will improve the overall quality of life. Combining these with electric distribution system level technologies such as a demand side management program can lead to further savings on the cost of purchased power, which would be reflected in your energy costs on your power bills. A prime example of a demand side management is the Cooperative's water heater load control program. Whenever there is a risk of reaching a system usage peak, the receiver attached to the water heater is activated. temporarily interrupting electricity. Since the water in the electric water heater stays warm

for several hours without power, most members never even notice the temporary shutdown. Purchase power costs for utilities are largely driven on peak usage. Load control or demand response programs help to flatten that curve, resulting in lower purchase power costs being passed down to our members. These pillars of beneficial electrification also place an emphasis on solutions that are better for the environment.

Converting from carbon based fuel sources to electricity that is fueled by a renewable resource, such as hydropower, could prove to be beneficial for the environment.
