2023 Annual Meeting Highlights

Steuben Rural Electric Cooperative held its 79th Annual Meeting at the Canisteo-Greenwood High School in Canisteo, which was also live streamed to our Cherry Creek members at the Pine Valley Central High School in South Dayton on Saturday, October 14, 2023. The Cooperative had a great meeting in which we shared with our members and guests the current status and future of Steuben Rural Electric Cooperative. Food, raffle prizes, gifts, and fun was enjoyed by all. The annual meeting provides members with the opportunity to get to know their cooperative.

The annual meeting was opened with the Pledge of Allegiance, followed by the invocation, offered by Pastor George Coon. Board President, James McCormick welcomed attendees to the meeting and introduced the Cooperative's board of directors, management, and special guests.

At the annual meeting, Cooperative members elected three of their peers to serve on the Cooperative's Board of Directors. In District 3, Edward Borkowski was re-elected. SOME COMMON QUESTIONS ABOUT CAPITAL CREDITS

What are Capital Credits?

Capital Credits are an allocation of funds that represent your share of the ownership in the Cooperative. *Capital Credits* can also be called equity or your investment in the Cooperative. Steuben Rural Electric Cooperative, Inc. is a member-owned, non-profit organization. At the end of each year and after all operating expenses have been paid, the remaining margins are allocated to each member based on the amount of energy purchased during the year. This allocation of margins is referred to as *Capital Credits*.

When Are Capital Credits Retired?

Capital Credit checks are mailed to members each September that the Cooperative makes a general retirement. Each September, SREC's Board of Directors evaluates how much to pay taking into consideration such factors as the impact on electric rates and financial strength of the Cooperative. Capital credits are refunded on a 25-30 year rotation. On September 29, 2023 Steuben Rural Electric paid over \$380,000.00 to members that used power in 1996 and a portion of 1997.

What Happens If You Move Off The Lines Of The Cooperative?

Your Capital Credits will be held in the account's name until they are refunded. You will receive a refund each year that the Cooperative makes a general retirement, mailed to the most current address on file. You must keep the Cooperative notified of address changes; otherwise, you may not receive your entitled refund check when mailed.

Five Ways to Safeguard Your Home This Winter

As the temperatures drop and the days grow shorter, there's a natural inclination to create a warm and cozy haven at home. Unfortunately, as we see increased use of heating equipment, candles and electrical items, the number of home fires tends to increase during winter months.

Here are five ways you can safeguard your home for the winter season.

1. Ensure carbon monoxide and smoke detectors are working

properly. If your detectors are battery-operated, replace the batteries annually. Test the detectors once a month and give them a good dusting to ensure the sensors are clear of dirt and debris.

2. Inspect electrical cords. We depend on more cords during winter, whether for holiday lighting, extension cords or portable heaters. Before using any corded items, double check to make sure cords aren't frayed or cracked. If you use portable space heaters,

remember to keep them at least 3 feet away from flammable items. Use models that include an auto shut-off feature and overheat protection. Space heaters can take a toll on your energy bills. Use them efficiently (to heat smaller spaces) and safely. Never plug a space heater into a power strip. Speaking of power strips...

- 3. Avoid overloading electrical outlets and power strips. When overloaded with electrical items, outlets and power strips can overheat and catch fire. If you use power strips for multiple devices, make sure the strip can handle the electrical load. For a safer bet, look for power strips that include surge protection.
- 4. Clean the fireplace to improve safety and efficiency. There's nothing better than a warm fire on a chilly night, but it's important to maintain your fireplace for safety.

As wood burns, a sticky substance known as creosote builds up in the chimney. When creosote buildup becomes too thick, a chimney fire can ignite. The chimney should be cleaned at least once a year to reduce fire risks. Regular cleaning also improves air flow and limits the amount of carbon monoxide that seeps indoors.

5. Practice safety in the kitchen. As we spend more time in the kitchen during the holiday season, be mindful of potential fire hazards. Never leave food that's cooking on the stove top unattended. Clean and remove spilled foods from cooking surfaces and be mindful of where you place flammable items like dish towels.

COOPERATIVE NEWS

Recently, the Cooperative announced that it would be holding two public hearings regarding a potential rate increase. The first rate hearing was held on November 29, 2023 in the Bath District and the second on November 30, 2023 in the Cherry Creek District. We would like everyone that took the time out of their today to attend and speak at these hearings. The public hearing process is critical in promoting transparency. Excellent questions comments were raised by all who attended these hearings.

After careful consideration, the Cooperative will be moving forward with implementing a 6.75% increase to the average, 1,000 kWh residential bill. The financial impact of this increase will be \$9.03 on the average bill. This rate increase will go into effect on the February 2024 billing statements and impact all rate classes and is split between the fixed charge and per kWh distribution charge. New rates would be as follows:

For those members that were unable to attend the public hearing, the Cooperative provided information on the proposed increase such as, the proposed rates, details on why the increase was found to be necessary, information on how to control your energy charges and a comparison to other local utilities. The need for an increase ultimately boils down to widespread inflation over the past few years and the current labor market.

From the gas pump to the grocery store, we've all seen costs going up. Pandemic-driven supply chain disruptions, a war in Ukraine, and skyrocketing natural gas prices have fueled inflationary pressures and cost increases in just about every sector, including the electric utility industry. In the last several years, costs for all materials and equipment have risen dramatically. As an example, the cost to purchase a 10kVA transformer (standard residential transformer) has risen by 100%, from \$650 to \$1,300, over the past 3 years. Similarly, the cost for a standard 40-foot wood pole has risen from \$330 to \$772, a 134% increase. In late 2019, we were purchasing 1/0 ACSR conductor (most common wire) for \$0.27/ft, which has since increased to \$0.55/ft, a 104% increase. These are just a few examples of our most utilized items on the distribution system that we use in basic maintenance procedures. These same kinds of increases are widespread and are not isolated to just a few items. As a result, the Cooperative needs to adjust member rates to provide adequate revenue for system maintenance, replacement, and repairs.

There is also a national shortage of qualified lineworkers. These are the individuals that keep our lights on and are in dangerously short supply. To compound the issue, the average time it takes from an apprenticeship to the beginning stages of working on energized electric lines is about 4 years. In addition, the level of federal funding is rapidly increasing the demand for qualified lineworkers. Electric distribution and transmission contractors are raising wages so high that lineworkers are now leaving their careers at investor-owned utilities. Investor-owned utilities are now, and have been, poaching lineworkers from rural cooperatives and municipal electric departments at higher wage rates. Our neighboring investor-owned utility is paying qualified lineworkers far above the Cooperative's current rate of pay. As such, we have had to increase lineworker compensation significantly, over the past few years to maintain a stable base of lineworkers, as has every other rural electric cooperative and municipality. Without qualified lineworkers, reliability of electric service would be compromised.

This is certainly not news that we enjoy delivering, but we appreciate the support of our members during this difficult time for all. As other local utilities have been raising rates by over 20%, the Cooperative has been hard at work trying to control costs in an effort to minimize the impact on our members. We will continue to do our part in carrying forward the Cooperative's mission of improving the quality of rural life by providing our members with low cost, reliable electricity, and related services in a safe manner.
