Cooperative News

Rate Increase Information

The Cooperative will be implementing a rate increase that will be effective on the July 2021 billing statements, after the traditional heating season. This increase is being implemented in accordance with Policy 218 of the Cooperative. As such, this increase will be less than 2.00% of the average 1,000 kWh residential bill.

The rate increase will be assessed on both the customer and distribution charge. The distribution charge is to recover the variable costs associated with maintaining and operating the Cooperative's distribution system to ensure reliable electricity is delivered to your home or business. The customer charge is designed to recover some of the fixed costs associated with the same. Since all our members need the distribution system available, even if they have little or no usage, we charge a base customer charge to help cover the costs of maintaining the Cooperative's system so it is there when you need it. If a member has little to no usage, there are still costs associated with operating and maintaining their line (i.e. property taxes, interest, customer service, billing etc.). A customer charge ensures that these costs are shared as equitably as possible. The overall impact of the rate increase on an average 1,000 kWh residential monthly bill will result in a \$2.41 increase.

This rate adjustment will allow the Cooperative to accomplish the goals of the 2020 budget, future forecasted system investments and offset continuously increasing costs. The Cooperative takes reliability seriously. To ensure that safe and reliable energy is delivered to your home or business when you need it, the Cooperative strategically plans continuous investments back into the system. That being said, we can assure you that the Cooperative is taking measures to decrease cost, without sacrificing service or reliability. Since December of 2014, the Cooperative has held controllable expenditures to an average of 2.19% growth, while expanding maintenance activities such as vegetation management and an increased frequency of significant storm events.

The Cooperative would like to avoid large rate increases, especially for those that are living on a fixed income. Therefore, our Board of Directors is continuously evaluating costs and rate adjustments to ensure that each member is receiving the best possible service at the least cost. As always, if you have any questions, concerns or comments please feel free to contact us anytime! We will continue to work hard to improve the quality of rural life by providing our members with low cost, reliable electricity and related services in a safe manner.

CONNECTED to SAFETY Making your Home Safe and Efficient While safety for our members is top priority year-round, Electrical Safety Month is a time to acknowledge the importance of safety excellence.

May is National Electrical Safety Month, and Steuben Rural Electric is joining with Electrical Safety Foundation International (ESFI) in launching its annual effort to help reduce electrically-related fatalities, injuries, and property loss. This year's campaign theme is "Connected to Safety," which educates members on the emerging technology that ensures their homes are prepared to keep up with today's energy demands.

Whether you're working from home, learning from home, or just spending more time at home, it is important to make sure your home is electrically safe, secure, and efficient. Members are spending more time at home than ever before, so it's imperative they don't overload their electrical systems and cut energy costs where they can. For example, air conditioning contributes to 17% of average yearly home energy usage, while space heating contributes to 15%, and lighting to 10%. Heating only the areas occupied with energy-efficient space heaters and utilizing home automation to control HVAC systems can improve your heating and cooling efficiency. Using energy-saving LED light bulbs and automated lighting will further promote safe and efficient energy use.

Home safety devices, including arc-fault circuit inter-

rupters, ground-fault circuit interrupters, grounded outlets, and surge protective devices, are an essential element in any smart home. These devices keep you safe from fires, electrical shock, and costly damages from power surges. As many members consider or purchase an electric vehicle, they should be aware of safe vehicle charging practices. ESFI recommends having a qualified electrician inspect your home to ensure your electrical system can handle electrical vehicle charging.

Electrical safety awareness and education among members, families, and communities will prevent electrical fires, injuries, and deaths.

Attaching Items to Utility Poles Presents Safety Hazards

Although it may seem innocent, placing signs and other items on utility poles creates a serious safety hazard. Drive down the road and you'll see utility poles covered with a wide range of signs.

You'll see everything from no parking to directions to a graduation party, balloons or a local yard sale. We have also recently noted many deer stands, bird houses and satellite dishes on poles, which can create a significant climbing hazard.

By attaching items to poles - from the tiniest of posters to something as large as a birdhouse or deer stand - you are risking the lives of others, especially the linemen, whose jobs are already dangerous. It may not sound like a big deal, but a small nail, tack or screw partially driven into a pole can tear a lineman's

glove and clothing, compromising their safety and making them vulnerable to electrocution.

Not only do the attachments put line crews at risk, but anyone placing items on poles comes dangerously close to energized power lines.



A secondary concern is that moisture and insects get into holes surrounding nails, damaging the poles and increasing maintenance costs.

The Cooperative appreciates your help in keeping utility poles clear and our linemen safe.
